	<p>CLIENT INFORMATION. Complete the Client Information Sheet (in folder)</p>	
	<p>DECLARATION. Review and Sign the “Declaration Regarding Electronic Filing” (in folder)</p>	
	<p>DISCLOSURE. Review and Sign the “Debt Relief Agency Disclosure” (in folder)</p>	
	<p>BANKRUPTCY ASSISTANCE SERVICES. Review and Sign the “Important Information About Bankruptcy Assistance Services” (in folder)</p>	
	<p>AGREEMENT FOR LEGAL SERVICES. Review and Sign the Agreement for Legal Services (in folder)</p>	
	<p>PROOF OF INCOME. Provide copies of paycheck stubs, or printout of income and deductions, for all earners in your household (even if not filing) from all sources of income for the previous six-month period (not counting the month in which your case will be filed). For example, if your case is filed in October, then you must provide proof of income from April through September.</p>	
	<p>TAX RETURNS. Provide copies of your tax returns, including all W-2s, 1099s, and other related forms, for the most-recent two years if filing under Chapter 7, or four years if filing under Chapter 13.</p>	
	<p>BANK STATEMENTS. Provide account statements for all bank and other depository accounts for the previous six-month period.</p>	
	<p>CLOSING STATEMENTS. Closing Statement (HUD 1) of property sold within the last two years (if applicable)</p>	
	<p>DIVORCE DECREE. Divorce decree and/or property settlements entered within the last three years, and alimony and child support orders (if applicable)</p>	
	<p>APPRAISALS. Appraisal or market analysis for all real estate in which you have any interest (if available and if less than 2-years old)</p>	
	<p>AFFIDAVIT. In Chapter 13 Cases, Review and Sign the “Affidavit Requesting Confirmation” (in folder)</p>	
	<p>LIFE INSURANCE. Provide the last statement from each Term or Whole life insurance policy (if applicable)</p>	
	<p>RETIREMENT ACCOUNTS. Provide the last statement from all IRA, 401k, annuity, pension, profit sharing or other retirement plans (if applicable). Include statements for any withdrawals made within the twelve months.</p>	
	<p>SELF EMPLOYMENT INFORMATION. If you own a business, have rental property or have more than one employer, please complete the “Supplemental Client Information Sheet” (in folder)</p>
